4. If these services (both Hard and Soft Facilities Management) are outsourced, please can you outline when these contracts were awarded, for how long, the contract value and when they are due to expire?

The PFI contact with NewHospitals expires August 2047. At the St Helens and Whiston Hospital sites all expenditure for these services are provided as part of the PFI agreement and as such are not discreetly identifiable.

The Patient Catering Service contract at Newton Community Hospital is until April 2025. The contract value is @ £190,000 p.a.

The Laundry Service contract at Newton Community Hospital for the inpatient ward is a rolling contract and is currently valued at @£20,000 p.a.
