REQUEST & RESPONSE

- 1. Please could you let me know the number of people in hospital with COVID 19 as of the 17th of October 2021 and 17th of November 2021 that are Vaccinated and not vaccinated? Please clearly break down the numbers of vaccinated or not vaccinated.
- The number of patients in the Trust recorded as positive for COVID 19 as at 17/10/2021 was 41.
- The number of patients in the Trust recorded as positive for COVID 19 as at 17/11/2021 was 61.

The Trust does not record this information on electronic systems therefore a manual audit of the patient clinical notes would be required in order to identify patients who were vaccinated or not vaccinated. This manual audit would exceed 18hrs therefor under section 12 of the Freedom of Information Act St Helens & Knowsley Teaching Hospitals Trust does not have to comply with providing the answer if we estimate that the cost of complying would exceed the appropriate cost limit of £450. 4. What capacity you have in your Covid wards and what amount of them are currently occupied.

We have 1 dedicated ward as a cohort which is a 33 bedded ward (excluding 2 beds). We are a hospital with 50% cubicle capacity meaning we were able to manage our COVID patients in cubicles on other wards. The Trust has an escalation plan which includes opening further COVID cohort wards to match growing numbers of positive patients requiring specialist care for COVID. Specialist care for COVID patients will always be provided by the Respiratory team

5. What is your capacity on your covid wards in comparison to April 2020, November 2020, April 2021 and November 2021.

As above, the Trusts capacity will depend on the number of positive patients requiring specialist care for COVID. Last year we had more wards open as COVID cohort to match the demand.

6. How many patients caught covid whilst in hospital?

The Trust does not record this information on electronic systems therefore a manual audit of the patient clinical notes would be required in order to identify patients who have caught covid whist in hospital.
